# "Jazz Age Dance Halls Viewed by Many as Menace to Society" 

## Materials

- Article: "Jazz Age Dance Halls Viewed by Many as Menace to Society," The Pantagraph, Aug. 17, 2008.
- Primary Document(s):
- Photograph: Dance Hall at Funk’s Grove, 1928 (p. 115 in Kemp)
- Photograph: Couple dancing
- Song: "Let's Misbehave" (music and lyrics by Cole Porter)

Procedure (approximately fifteen minutes -in three five-minute increments)

- Students will begin by reading the article, and could be encouraged to annotate/highlight if appropriate.
- After they have been given approximately five minutes to read the article, hand out the song lyrics for students to read. The teacher could play the song for students while they read, if the YouTube link to the song is available or if they have access to the song in other forms.
- When students are finished reading the lyrics and listening to the song, teachers will engage the students in a brief discussion over the connections students made between the content of the article and the lyrics (e.g., the suggestive nature of the song's lyrics and its title reveal traces of modernity in popular culture feared by some in the community), with the intent of connecting the article and song to larger issues of American culture in the 1920s.

## Glossary:

Gallivanting: Go around from one place to another in the pursuit of pleasure or entertainment.

Contaminated: Make (something) impure by exposure to or addition of a poisonous or polluting substance.

Illicit: Forbidden by law, rules, or custom
Convergence: Moving toward union or uniformity

Pathological: Being such to a degree that is extreme, excessive, or abnormal

Unincorporated area: A region of land that is not governed by its own local municipal corporation which is instead administered as part of larger administrative divisions, such as a township, parish, borough, county, canton, state, province or country.

Supplanted: To replace (one thing) by something else.
